TERMS AND CONDITIONS OF CREDIT FROM WHITFIELD OIL CO., INC.

In consideration of the terms of sales, herein and for the extension of credit by Whitfield Oil Company, Inc., the undersigned as an approved representative of Applying Company (hereinafter referred to as the Applicant) agrees to pay for all purchases in accordance with the terms and conditions set forth below. The Applicant assumes full responsibility for payment of goods delivered to the Applicant's place of business or location provided by special instruction from the Applicant or any approved agent of the Applicant. The Applicant agrees to notify Whitfield Oil Company, Inc. within 24 hours of any shortages of product delivered, and ten (10) business days of any discrepancy in billing invoice.

TERMS

- ✓ Credit extended for wholesale **fuel** and **gasoline deliveries** are due NET TEN (10) days from the date of delivery.
- ✓ Fastway Account terms are EFT (Easy Pay) on the 15th of the billing month.
- ✓ Credit for lubricants and other products are due NET THIRTY (30) days from the date of delivery.

A finance charge of 1 1/2% will be charged to all accounts not paid by the due date. This is an annual percentage rate of 18%. Based on Whitfield Oil Company's credit standards, delinquent accounts will be placed on credit hold until said account is brought current. At any time, the Applicant may be required to remit payments via electronic funds transfer (EFT) to clear outstanding lubricant or fuel balances that are past due.

CREDIT POLICY

Credit Lines will be established and based on information the Applicant supplies to us, and through reports from Equifax or another credit reporting company. Credit lines will be updated on a need be basis. Your assigned Account Representative may ask for a prepayment check should the credit limit be reached before further shipments are made. Permanent loss of credit may occur if frequent delinquencies occur.

BILLING

It is the Applicant's responsibility to ensure Whitfield Oil Company, Inc. has correct and current billing information and to issue payment within the Terms listed above. Failure to receive an invoice does not relinquish responsibility from payment. Statements are mailed monthly by request. Statements are for account information only and are not for billing purposes. Any past due invoice listed on a statement is due immediately.
